SI. No.	GENERAL CONDITIONS - The school is directed to ensure that :
1.	The total number of section of the school shall be restricted to 12 (As per prescribed dimension) as per the number of class rooms reported during inspection and further increase shall be subjected to specific approval of the Board on the basis of the request of the school as per affiliation by laws.
2.	Compliance of the points no. 1 to 11 may be submitted within 03 months on the SARAS Portal, failing which due action will be taken.

SI. No.	CONDITIONS FOR COMPLIANCE
1	The total number of sections of the school shall be restricted to 12 (as per prescribed dimensions) as per the number of class rooms reported during inspection and further increase shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation by laws
2	The School's mandatory disclosure link is non-functional. The School should maintain functional website and mandatory link and submit compliance with in 3 months.
3	The School needs to upgrade the Maths lab as per Board's SOPs and submit compliance within 3 months.

4	The school library is still under stocked and not organized properly. No separate reading space for staff is seen. The school shall upgrade the library as per SoP issued by the Board within 3 months and submit compliance on SARAS.
5	A ramp at the ground floor is seen at the side/back of the building. The school shall also construct a ramp at the main entrance of the school building within 3 months and submit compliance on SARAS.
6	The signage on CWSN toilets is inappropriate and temporary. The school shall affix proper and permanent signage on CWSN toilets indicating the floor number, as per norms of RPwD Act and guidelines issued by the Board within 3 months and submit compliance on SARAS.
7	Non-compliance of the deficiencies within a period of 3 months shall attract financial penalty.
8	The fire safety certificate submitted by the school mentions the school building having G+2 floors. However the ramp and CWSN toilets have been made at ground and first floor only. If the second floor is not in use presently, the school shall ensure that CWSN facilities like ramp and separate toilets are made available for that floor in the future when it is put to use.
9	The school shall get all the mandatory certificates renewed periodically.
10	The school shall conduct training of its teachers with Chandigarh CoE within 3 months and submit the compliance on SARAS.
11	The school shall not remove the videography links in the mandatory disclosure section of its website

"Keeping in view the above said facts and circumstances, the present petition is disposed of with a direction to the Secretary, Department of School Education to consider and decide the representation dated 12.01.2023 (Annexure P-11), in accordance with law within a period of six weeks from the date of receipt of the certified copy of the present order. While taking a decision, the judgment of the coordinate Bench of this Court passed in CWP no.12389 of 2021 titled as "Ameliorating India, NGO vs. State of Punjab and others" decided on 02.11.2021 (Annexure P-8) be also taken into consideration."

2.0 The Federation of Private Schools and Association of Punjab filed a Civil Writ Petition no. 7238 of 2023 before the Hon'ble Punjab and Haryana High Court with the prayer to issue permanent recognition orders to members of the petitioner Federation in terms of the Right of Children to Free and Compulsory Education Act, 2009, and further, to issue recognition orders without incorporating the word 'provisional'.
